OBJECTION TO REFEREE'S RECOMMENDATION

The enclosed form: OBJECTION TO REFEREE'S RECOMMENDATION is to be used when you are objecting to the recommendation and purposed order.

Contact your Judge=s judicial assistant to schedule a hearing before the Judge regarding your objection. A **NOTICE OF HEARING** is enclose which you will need to complete

1. FILLING IN THE FORM [please type or print clearly]
 - A. Provide your full case number, including the 2 letters at the end e.g. DM, DS, etc
(_ - _ _ _ _ _ - _ _)
2#s / 6 numbers / 2 letters
 - B. Fill in the name of your Judge (not the referee=s name).
 - C. Provide all information about the parties to the case in the boxes at the top, including address and attorney. (If there is information you do not know put UNK, if the information does not apply put NA).
 - D. Your court order will indicate whether you are the Plaintiff or Defendant.
 - E. Fill out #1 by printing/typing your name, the date of the recommendation and by checking all boxes that apply to your objection.
 - F. State the specific reasons for your objection. You may add extra sheets. Simply stating you disagree is not sufficient. You must be specific as to what was improper and why.
 - G. In #3 state clearly and specifically what you would like to the court order to provide
 - H. Date and sign the objection form.
2. Make at least **five copies** of the objection and notice of hearing form AND the same number of any extra sheets or other documentation attached which you use to support your position.
3. Take your original(s) and five copies to the County Clerk=s Office at the VETERANS MEMORIAL COURTHOUSE at 313 W Kalamazoo Street, Lansing.
4. The clerk will keep the original and one copy, returning four to you. **KEEP ONE AS YOURS!**
5. You must serve [mail by first class] a copy of the objection and any attachments to the other party. If there is a custodian or guardian who has care or custody of the child(ren) they must also receive a copy. ***These materials MUST be mailed to the other party[ies] at least 9 days [not including holidays] before the hearing date you have set in step 1 above.***
6. You should still have your copy and two others. Fill out the CERTIFICATE OF MAILING at the bottom of the objection by dating (this is the date you mailed the objection form to the parties) and signing. Return to the County Clerk and present two of these - one is for the Court file and one is for the Friend of the Court.
